■ KINDS OF PERSONAL DATA HELD

There are several categories of personal data held in us:

- A. email address.
- B. device identifiers (such as IDFA, IDFV for Android, GAID for IOS).
- C. behavioral usage of the App.
- D. the type, version, brand, language and operating system of device.
- E. the type and operator of network (such as Mac address).

■ PURPOSES OF KEEPING THE DATA

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances:

- A. Where we need to perform the contract we are about to enter into or have entered into with you.

- B. Where we need to comply with a legal or regulatory obligation.
- C. Where it is necessary for our legitimate interests (or those of a third party) and your interests and fundamental rights do not override those interests.

■ DISCLOSURE OF THE DATA

We may have to share your personal data with companies within our group. We require all third parties to respect the security of your personal data and to treat it in accordance with the law and this Policy. We do not allow our third-party service providers to use your personal data for their own purposes and only permit them to process your personal data for specified purposes and in accordance with our instructions.
